Case Summary:

A boat to boat incident between boats approaching and boat leaving the windward mark.

Procedural Matters:

Cases 19, 20 and 22 were heard together

Facts Found:

1. In race 4 approaching the windward mark with approximately 7 knots of wind, flat water.
2. BRA 12 rounded the windward mark 1, clear ahead of SWE 77, both on starboard tack.
3. Both boats gybed to port tack soon after rounding.
4. SWE 77 established an overlap to windward of BRA 12.
5. Both boats luffed.
6. They were now heading toward GBR 24 close-hauled course on the starboard layline to mark 1.
7. 5 sec after SWE 77 and BRA 12 rounded the mark there was a contact between the wings of the two boats.
8. At this moment SWE 77 and BRA 12 were pointing to windward of GBR 24, 2.5 boat lengths away.
9. SWE 77 and BRA 12 bore away.
10. There was a contact between the wings of SWE 77 and GBR 24.
11. The trapez wire bungee of GBR 24 broke in the incident.
12. No boat took a penalty.

Conclusion & Rules:

- 1. SWE 77 to windward failed to keep clear of BRA 12 to leeward, and broke RRS 11.
- 2. SWE 77 on port failed to keep clear of GBR 24 on starboard, and broke RRS 10.
- 3. SWE 77 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 4. GBR 24 was an obstruction to BRA 12 and SWE 77. From the time the overlap began, BRA 12 was unable to give room for SWE 77 to pass GBR 24. So, BRA 12 did not break RRS 19.2(b).
- 5. It was not reasonably possible for GBR 24 as the right-of-way boat to avoid contact with SWE 77 when it was clear that SWE 77 was not keeping clear. GBR 24 did not break RRS 14.
- 6. BRA 12 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 7. Since BRA 12 was right-of way boat and the contact did not cause damage or injury, she is exonerated under RRS 43.1(c) for breaking RRS 14.
